2. that the society shall provide the necessary amenities like accommodation, sanitary facilities, drinking water facilities, furniture, library, laboratory equipment play field required staff as per the staff pattern and other facilities are necessary, before approaching the competent authority.

3. that the Society shall apply for recognition by 60 days at the latest duly fulfilling the condition.
4. that the permission accorded is restricted to this year only and it is not valid for the subsequent academic year.
5. that this permission does not confer any right on the Society for claiming recognition.
6. that the permission is accorded to DAV College Trust & Management Society and no other society or body can open a school on their behalf.
7. the permission is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
8. the Society shall provide the necessary material even if it costs more than the deposit amount.

Permission has been accorded for starting with classes I to V (E.M.) by the District Educational Officer, R.R. District, Sec during the year 1992-93 in the order first cited. The Proposals for grant of Provisional Recognition to the school for the year(s) 1993-94 to 1997-98 has been received vide reference 2nd cited. The proposals have been verified and referred to Mandal Educational Officer to visit the school and submit a detailed Inspection Report to grant of Provisional Recognition in accordance with GO Ms. No. 1/Edn., dt. 1.1.1994 vide reference 3rd cited. The Mandal Educational Officer, MP Rajendranagar has submitted the proposals vide reference 4th cited with reference to the conditions laid down in the permission order first cited and as per GO Ms. No. 1/Edn dated: 1.1.1994.

After careful examination of the references cited and the conditions prescribed in GO Ms. No. 1/Edn., dt. 1.1.1994, the competent authority hereby accords provisional recognition for a period of 5 years commencing from the academic year 1993-94 to 1997-98 for class I to V (E.M.) in respect of D.A.V. School, Kukatpally.

1. that the Society shall abide by the instructions/rules and regulations made by the Government or Authorised Officer time to time.
2. that the educational institution shall serve the needs of the locality more particularly.
3. that the institution shall adopt the curriculum and syllabus prescribed from time to time.
4. the school timings, vacations and mid-term holidays shall be as prescribed by Government from time to time.
5. that the qualified staff within the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.

6. that the results of institution shall satisfactory every year.
7. that the records/accounts shall be furnished to the D.E.O. every year by end of academic year at the latest.
8. that the list of governing body shall be furnished to the D.E.O. every year.
9. that the pay structure/fee structure fixed by the governing body shall be get approved by the D.E.O. every year.
10. that all the conditions prescribed in the G.Os and other orders which are unspecified in this orders shall be complied with.
11. that the school shall not be closed without giving notice both to the parents/DEO and competent authority atleast 6 months before.
12. that the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. that the Society shall submit proposal for a renewal of provisional recognition sufficiently in advance i.e. atleast 6 months prior to the date of expiry of the renewal.
14. that the management should maintained Service Registers in respect of all teachers.

The recognition now granted is liable for withdrawal by the competent authority for violating the rules as prescribed in the G.O.5th cited and instructions issued by the authority from time to time.
